MINUTES OF THE MEETING

- > The meeting commenced with the Director Principal welcoming everyone for the Parent Reps Meeting.
- > Feedback / Suggestions of Parents were taken up:
 - School action regarding the bus drivers and helpers: Ms. Aditi Misra responded that the school has been following the Surakshit Vahan Policy which met stringent checks on the drivers / helpers daily. This agitated them as anyone who was checked did not like it. Therefore, for the safety and security of the students, the management decided to take action.
 - Regarding Social Media and Smart phone usage: Ms. Aditi Misra informed all
 present that smart phones and availability of unsupervised internet usage has led
 to some students sending inappropriate messages to each other. The parents
 wanted the school to intervene or they would go to the police and complain.
 Inspite of the school requesting parents not to provide smart phones, the students
 still have them. In such cases, where there is misuse of social media, from home,
 the school cannot be responsible.

In continuation with the above, it was decided by the Parent Rep Group that all internet related work for students will be done in school or given for home work during weekends / holidays.

- > The class X and XII results of the students were discussed and appreciated by all.
- > The college placement of the students of 2019 batch were noted by all.
- ➤ The Director Principal shared the details of the admission process for classes Pre Nursery and Nursery (session 2020-21). The Draw of Lots would be held in the auditorium of DPS Sector 45 on Saturday, 7th September'19.
- Ms. Aditi Misra informed everyone, that as promised, the proposed fee for session 2020-21 will be as follows:

7% increase in Tuition Fee

10% increase in Bus Fee

No increase in Annual Fee or any other charge

6% increase in the Refundable Caution Money for New Admission students only The proposed fee structure was approved by the Parent Reps. The fee structure will now be presented for ratification by the Members of the Managing Committee of DPS Gurgaon.
